I/WE HEREBY RELEASE, WAIVE, COVENANT NOT TO SUE AND DISCHARGE the promoter, participants, sanctioning organization or any subdivision thereof, officials, vehicles, owners, riders, promoters, sponsors, advertisers, owners, lessees of premises used to conduct the event and each of them, their offices and employees, all for the purposes therein referred to as "Releases" from all liability to the undersigned, or damage and any claim or any demand on account of any injury to the participant included, but not limited to, death whether caused by the negligence of the "Releasees," or otherwise while the minor is competing, officiating in, observing, working for or for any purposes participating in the event.

The undersigned expressly acknowledge and agree that the activities of the event are very dangerous and involve the high risk of serious injury and/or death and/or property damage.

Each of the undersigned parents or legal guardians for the minor participant agrees to indemnify and save and hold harmless the "Releasees," and each of them from any loss, liability, damage or cost they may incur due to the presence of the said minor in any way competing, officiating, observing or working for any purpose participating in the event and caused by the negligence of the "Releasees" or otherwise.
